**Fields of competence:** Professor Maubernard is teaching European Union Law (both institutional and substantive Law) as well as International Economic Law. His main fields of researches are the effectiveness of fundamental rights within European and International Law, the quality of standards (especially human rights' norms) and the role of judges in human rights' empowerment. He worked for the former European Commission of Human Rights (Council of Europe, Strasbourg) and the European Parliament (EU, Brussels). Professor Maubernard is belonging to the **Institut de Droit European des Droits de l'Homme** (IDEDH, Human Rights' European Law Institute).

# The university and the city

The Faculties of Law and Political Science and Medicine are among the oldest in France. They were created at the same time as those of Bologna in Italy. The Faculty of Law has around 9000 students from the first year to post-doctorate. Three main departments are represented: Law (public, private and international Law), History Law and Political Science. The Faculty of Law is located in the historical center of Montpellier, which is entirely pedestrian.

The Faculty provides to the students access to libraries, both the general library with all the catalogues and the specialized ones (for instance the Human Rights European Law Institute holds a very rich collection of books and reviews, both in French and English, concerning aspects of protection of human rights).

The city is located in south of France between the mountains of "Cevennes" and the Mediterranean Sea. The weather is quite warm from April to the end of October. A tramway can easily bring the students outside the center, even close to the sea which is about 10 miles from the city. All the courses are 30 hours (main courses) or 20 hours (seminars).

Deadline for enrolment in the courses: For the 2018 second semester the courses will begin on Monday 15<sup>th</sup> of January and will end on Saturday 14<sup>th</sup> of April. The EMA students can foresee a week off (from 26<sup>th</sup> of February to 6<sup>th</sup> of March). The students from Venice can expect also to receive, as they arrive later, a resume of courses by professors.

**Examination procedures: Oral examination**. The examinations take place most of the time between the end of April and the end of May. The EMA students are enrolled under "Erasmus" status. Each course is 6 ECTS, which means in accordance with EMA convention, that **the EMA students are expected to choose at least 2 general courses** (and more if interested).

# Specific resources

In order to facilitate their arrival and their stay, the Institute will set at its expenses some specific costs for photocopies, French language courses, and if justified some travel expenses. Two years ago, the Faculty has also signed a convention with one of the student residences, which is about 10 minutes' walk from the Faculty and has very competitive prices (this residence was closed this year but will be re-opened next academic year).
